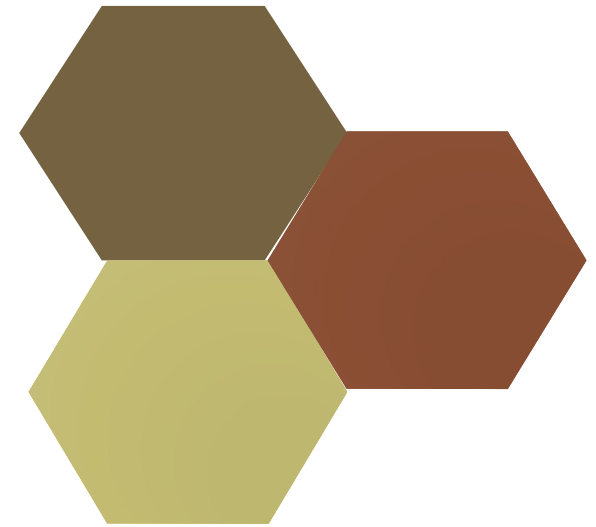

1. Overview



What does the GITP cover?

The GITP covers :

- (a) Supply of IT products
- (b) Provision of support services
- (c) Provision of maintenance services
- (d) Provision of trade-in services





How does the GITP work?

- OGCIO maintains a list of registered IT suppliers (referred as GITP providers) under **each sub-category of GITP** for procurement of IT products by government bureaux and departments (B/Ds).
- Each GITP provider under each sub-category can provide a list of offered products as sample products for reference by B/Ds.

How does the GITP work? (cont'd)

- All B/Ds can invite GITP providers under a sub-category for proposals for their required IT products and related services. For each invitation, B/Ds are required to invite all GITP providers under the sub-category through the e-Procurement System of OGCIO.

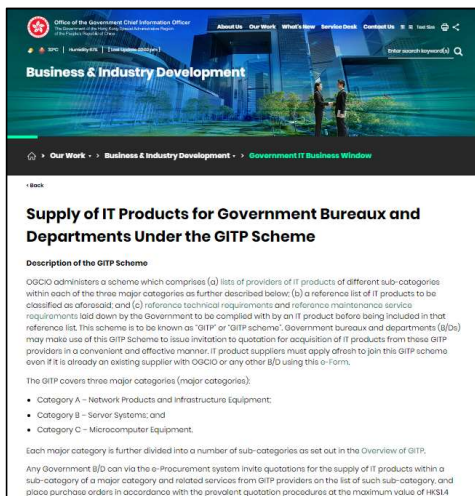

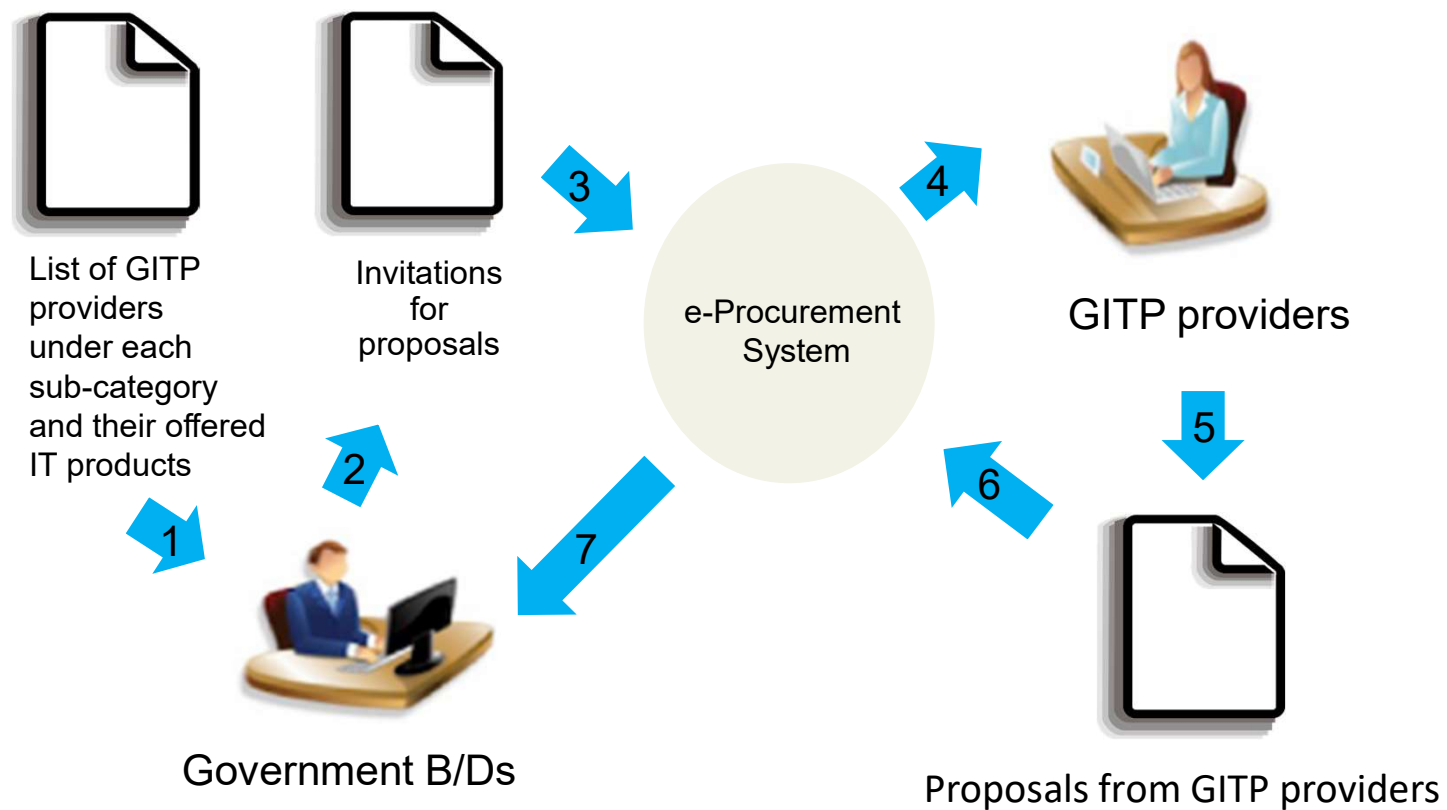

Acquisition of IT products by B/Ds through GITP

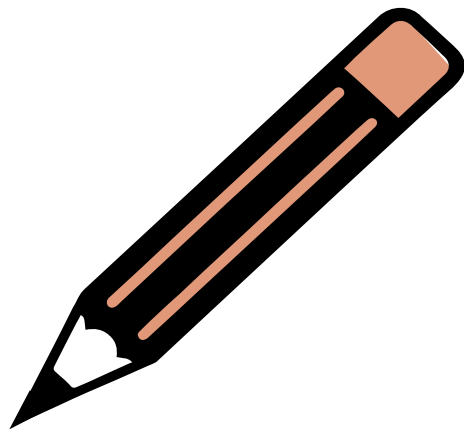


Individual procurement by B/Ds under GITP

- A maximum value of \$1.4 million ## per each acquisition (## revised to \$1.36 million in 2024)
- B/D can tailor/add technical specification of items within the scope of the sub-category
- B/D are required to invite all GITP providers under one sub-category
- Bidding by GITP providers is not compulsory; GITP providers can propose products not on their product list
- Award to conforming proposal of the lowest offer (if marking scheme is not used) or the highest combined score (if marking scheme is used)

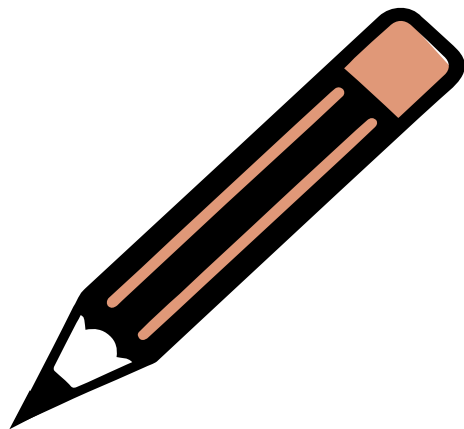

Monitoring of GITP providers' performance

➤ **Two independent review committees:**

1. Reporting Review Committee (RRC)

- To review the performance of the GITP providers and determine the delisting actions on GITP providers;
- To escalate any complaint/appeal to the MRC for further review

2. Management Review Committee (MRC)

- to review the complaint/appeal escalated from RRC and determine the final decision

- ◆ Details are given in the “**Regulating and Monitoring Mechanism of GITP**” on the GITP theme page.

Monitoring of GITP providers' performance (Cont.)

➤ **Contractor Performance Appraisal Report (CPAR)**

- B/Ds are required to submit CPARs at completion (or termination) of individual contract to evaluate the performance of the GITP providers
- An adverse CPAR is a CPAR rated as “Not satisfactory”

➤ **Counting adverse CPAR**

- During a rolling period of 180 calendar days, if the accumulated number of adverse CPARs is more than 10, RRC will further review and investigate the case
- A GITP provider may be removed from the list for 90 calendar days subject to the decision by the RRC
- Any complaint/appeal cases will be escalated to the MRC for further review and final decision

Retention of GITP providers

GITP providers are required to :

- verify and update their company information at a **two-year interval** upon request from OGCIO
- submit a duly signed declaration form confirming their compliance with the retention requirements and provide updated company information within one month



2. Admission requirements



Requirements on the applicant

- Valid Business Registration Certificate (BRC)
- Or exemption document under the Business Registration Ordinance (Chapter 310 of the Laws of Hong Kong)



Requirements on IT Products



- may apply for inclusion in one or more sub-categories of one or more major categories
- must propose at least one model for each IT product item designated as “requisite for admission” which shall be compliant with the reference technical requirements of the sub-category

Notes:

- (1) an IT product will be classified into one sub-category only;**
- (2) please refer to the reference technical requirements of IT products for detailed technical requirements of IT products.**

Items “requisite for admission”

- Those are **marked with an asterisk** in reference technical requirements of IT products
- Must propose **at least one** model for such item



1.1 Sub-category A1 - Network Router and Switch

1.1.1 Router [Item No. 11000] *

Network Interface	■ Provide at least two (2) GbE optical or electrical interfaces
Routing Protocol	■ Able to run OSPFv3 or multiprotocol BGP
High Availability	■ Able to handle VRRP
Form Factor	■ Rack mount
Others	■ Bundled with all necessary cables and accessories including rack mount kit
Green Features	■ Shall comply with mandatory requirement of Green Product Code D03

1.1.2 Router Accessory 1 [Item No. 11011]

Feature	■ One (1) power supply unit
Compatibility	■ Compatible with the proposed router [Item No. 11000]

Items “requisite for admission” for sub-category B4

- For sub-category B4 (Server Application Software), IT suppliers can propose **any** one of the server application software within the sub-category.

Note: For admission to GITP, the proposed software must include the main application software running on the computer server (i.e. Just the client/device access license of the server application software only is not acceptable).

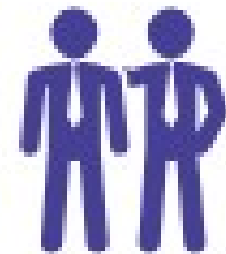


Requirements on Support Staff



- One Programme Manager
- At least one technical staff
 - Category A: Network System Engineer
 - Category B & C: Computer Hardware Engineer/ Computer Software Engineer

Programme Manager	At least 4 years of IT experience, including at least 2 years of IT project management experience
Technical Staff	At least 3 years of IT experience, including at least 2 years of experience in the relevant function/speciality with valid and recognised professional qualification(s)



3. Application procedure



Steps for applying as GITP provider



- (a) Submit application by IT supplier
- (b) Approve application by OGCI0
- (c) Sign the document “Request for Inclusion” by IT supplier
- (d) Register to the e-Procurement System of OGCI0 by IT supplier

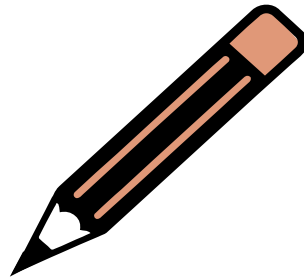

(b) Approve application by OGCIO

- The application submitted by IT supplier will be processed by the OGCIO.
- IT supplier may be requested to provide further information where necessary.
- The estimated processing time for each application is around two weeks.

(c) Sign the document “Request for Inclusion”



After the application is approved, the IT supplier is required to sign an undertaking to confirm its agreement to the GITP Scheme Participation Terms and Conditions.

(d) Registration in the e-Procurement system

- GITP provider will be provided with an account in the e-Procurement system (e-PS) of the OGCIO for receiving invitations from B/Ds and submitting proposals to B/Ds.
- GITP providers which are prevailing SOA/GLD contractors can use their existing e-PS accounts.
