A. Promote Wider Adoption of Cloud Computing

Planned Work 1: Promulgate more use cases of cloud services

- Solicit more use cases and success stories
 - The Secretariat will approach all members of EGCCSS and its WGs as well as the Government Public Cloud Services Providers to call for contribution of use cases and success stories
 - ICT Award Winners would be contacted to solicit use cases and success stories on cloud adoption
 - Planned: to publish use cases and success stories on InfoCloud Portal by Q2 2015



A. Promote Wider Adoption of Cloud Computing

Planned Work 2: Develop tools to promote adoption

- HK/GD Practice Guide for Procuring Cloud Services
 - Support the collaboration under the HK/GD Cloud Expert Committee to compile a practice guide for procuring cloud services applicable to both HK and GD
 - Provided comments and advices to the HK/GD joint task force on the first draft of the Practice Guide
 - Planned: To provide comments on the third draft (Simplified Chinese version) in Oct 2014 and the Traditional Chinese version in Q1 2015



A. Promote Wider Adoption of Cloud Computing

Planned Work 2: Develop tools to promote adoption

- Motion graphic video on the Practice Guide for procuring Cloud Services
 - Comments from WGPIUCS members collected
 - Under final refinement by the student team of HK Design Institute
 - Planned: To be published on InfoCloud Portal in Oct 2014
- As the HK/GD Practice Guide for Procuring Cloud Services will be compiled by the HK/GD joint task force shortly, there is a chance of promoting cloud services riding on this new tool. The WGPIUCS will advise, raise proposals, and to provide guidance on the promotion of cloud adoption and promotion materials
 - Planned: To advise and raise proposals on the promotion activities and programme riding on the HK/GD Practice Guide for Procuring Cloud Services in Q1 2015



B. Promote Development of Cloud Services Provisioning

Planned Work 3: Identify success cases to promote awareness on inter-cloud interoperability / portability and Data as a Service

- Explore cloud interoperability and portability testing opportunities with Cyberport Community Cloud
 - OGCIO is exploring the use of the Cyberport Community Cloud which provides tools for porting a new web service (called Address Lookup Service (ALS)) to public cloud platform for production run.
 - Planned: Q1 2015
- Promulgate experience on interoperability, portability and open data
 - Solicit and promulgate success cases on interoperability, portability and open data
 - The experience gained in the porting of the ALS to public cloud through the Cyberport Community Cloud
 - Solicit more real cases on interoperability, portability and open data in adopting cloud services
 - Planned: Q3 2014 Q2 2015



C. Promote Adoption of Standards and Best Practices

Planned Work 4: Promote awareness and adoption of international standards on cloud computing (such as ISO/IEC 17788, 17789 and IEEE P2301, P2302)

- Keep surveillance and sharing among Working Group Members on the development of cloud computing standards and issues for deployment in the local industry
- Disseminate updates of international and industry standards on InfoCloud Portal regularly
- o Planned Q4 2014- Q2 2015

Planned Work 5: Study on the Challenges and Problems faced by Cloud Professionals and Industry
