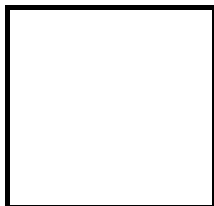

於二零零八年三月三十一日前已獲編配碼位的《香港增補字符集》字符，一概不受影響，繼續使用。

*Notes:

In view of the inextensibility of the Big-5 code points in the User-Defined Area reserved for the Hong Kong Supplementary Character Set (HKSCS), the CLIAC will only continue to provide HKSCS ISO/IEC 10646 version related support starting from 31 March 2008. All newly accepted HKSCS characters after 31 March 2008 will not be assigned Big-5 code points.

All code points assigned to the HKSCS characters before 31 March 2008 will not be affected.
